SUBJECT: Use of Cable Government Access Channel

Recommendation:

That Council provide direction for staff on the use of the government access cable channel 192

Summary

At Council's work session on October 27, 2020, Council discussed the proposal from a private individual whereby the City would enter into an agreement with a non-profit organization to manage and provide content for the City's cable television channel. The individual's concept is to provide programming including news, weather, election results, arts and entertainment, high school sports, and more, which may be inconsistent with education and government programming required by the City's franchise agreement. The funding is proposed to come from private donations, grants, corporate sponsorship, and fundraising activities.

Per Council request, staff has conducted additional research on whether the City can enter into a contract with a private organization to manage Spectrum cable channel 192, which is dedicated to the City of Casper as an educational and government channel (EG) per Spectrum's franchise agreement with the City. The following are staff's findings:

- A request for proposal would be required so that there is an opportunity for others to submit a proposal to manage the EG channel.
- Agreements could only be entered into with a non-profit organization for a specified duration.
- The non-profit would be required to have financial viability (capital and operational) on hand at the time of the proposal acceptance. All proposals may be declined.
- The programming would be limited to EG, which would narrow the programming that could be broadcast. No public access or programming could be allowed.
- The City would not have any editorial control over the content of the broadcast including negative stories about the City and its elected and staff.
- In discussing the concept with Spectrum representatives, there would be a limitation on funding such that only the PBS model of donors and grants and no advertising could be used
- Insurance and bonding as well as transparency in funding requests and expenditures would be required. This would not be a private television station

- operation and not capable of replacing KTWO Television or any other private television station Casper has lost.
- If cable franchise fees are affected or the City is reasonably threatened with loss of franchise fees due to the management arrangement or management conduct, then the contract ceases immediately and related television broadcast equipment of non-profit organization becomes the property of the City of Casper.
- Staff off the non-profit organization managing cable channel 192 will need remote access to City Hall equipment needed to broadcast. By necessity, use of the City's media room space must be secured and access limited.

Financial Considerations

The petitioner has indicated no financial commitment would be required of the City. Investments from the City to cable channel 192 are not budgeted.

Recommendation

That Council approve the request to move unspent monies from the Hogadon Parking Lot project to the Casper Ice Arena Ice Plant Replacement project.

Summary

The Hogadon Parking Lot project (#2250020006-102) was completed last summer and \$29,524 in funds remained at its conclusion. The Ice Plant Replacement project at the Casper Ice Arena has used its entire contingency and now requires \$21,079.31. The substantial completion date for the ice plant was November 16, 2020.

Staff wishes to use the funds left over from the parking lot project to supplant the contingency for the ice plant replacement project.

Financial Considerations

Total expenditures on Ice Plant Replacement Project \$2,573,060.58

While the cost of the project requires more funding, the overall proposition is budget neutral.
