Summary

On October 15, 2019, City Council approved the transfer of retail liquor license No. 18 Ridleys Family Market located at 3037 CY Avenue. However, the correct address which was listed on the application is actually 3035 CY Avenue. The original memorandum contained a simple scrivener's error on the last digit of the address. However, as described in the memorandum it is the old Blockbuster Video store. In fact, both 3035 and 3037 are located in the same building.

Originally, the license was to be transferred on October 28, 2019. With this discovery, the transfer will have to be delayed until October 30, 2019. The applicant has been advised.

#### Summary
