SUBJECT: Agreement with Athletica Sport Systems, Corp.
Casper Events Center Dasher Boards and Ice Cover, Project No. 14-28B

Recommendation:

That Council, by resolution, authorize an agreement with Athletica Sport Systems, Corp., for the Casper Events Center Dasher Boards and Ice Cover, Project No. 14-28B, in the amount of \$426,945.

Summary:

On Tuesday, June 24, 2014, two (2) bids were received for the Casper Events Center Dasher Boards and Ice Cover Project. The project consists of supplying and installing one (1) complete dasher board 85' x 200' removable system; team boxes; penalty boxes; scorekeeper's box; camera box; cast acrylic spectator shielding; ice dam; transport/storage equipment; attic stock of spare components; and netting system.

The bids received for this work are as follows:

The City's consultant for the project, International Coliseums Company (ICC), evaluated the bids based on pre-qualifications, material system, expertise of installation, quality and accuracy of the company's response to schedule, and cost proposal. ICC recommends award of the contract to Athletica Sport Systems, Corp. Becker indicated they could not meet the project schedule.

This project is the procurement and installation of the removable dasher board system, acrylic spectator shielding, ice cover and netting system. Another contract will be let to award construction of the chiller room and cooling tower pad. The engineer's estimate for the dasher board system was \$370,000, and the engineer's estimate for the ice cover was \$125,000, for a total estimate of \$495,000. The remaining portions of the project to still be bid out are the chiller room and cooling tower at an estimated cost of \$130,000 and the rubber flooring at an estimated cost of \$60,000. Accounting for a contingency of \$50,000 and already encumbered funds of \$237,000 for design and construction administration fees, the ice floor demo and refrigeration package of \$1,547,341, bid price for a new Zamboni of \$101,550 the estimated total cost of the

ice sheet at the Events Center is expected to be \$2,595,836. These costs do not include the cost of a storage building to store the equipment for the ice floor.

Funding for the project will come from a \$1,000,000 donation from John Wold, with the balance coming from Capital Project fund reserves.

A resolution is prepared for Council's consideration.

RESOLUTION NO. 14-187

A RESOLUTION AUTHORIZING AN AGREEMENT WITH ATHLETICA SPORTS SYSTEMS, CORP, FOR THE CASPER EVENTS CENTER DASHER BOARDS AND ICE COVER, PROJECT NO. 14-28B.

WHEREAS, the City of Casper desires to purchase and install one complete dasher board system and ice cover at the Casper Events Center; and,

WHEREAS, Athletica Sports Systems, Corp., is able and willing to furnish and install the removable dasher board system and ice cover as part of the Casper Events Center Refrigerated Ice Floor, Project No. 14-28B; and,

WHEREAS, it would be in the best interest of the City to expedite changes in the project by allowing the City Manager to sign change orders effecting time extensions of no more than thirty (30) days, dollar amount changes no greater than Twenty Thousand Dollars (\$20,000.00) and other project administration related change orders that do not substantially alter the scope of the project.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF CASPER, WYOMING: That the Mayor is hereby authorized and directed to execute, and the City Clerk to attest, an agreement with Athletica Sports Systems, Corp., for those services.



BE IT FURTHER RESOLVED: That the City Manager is hereby authorized to sign change orders effecting time extensions of no more than thirty (30) days, changes in the dollar amount of the above described agreement not greater than the sum of Twenty Thousand Dollars (\$20,000.00), and other project administration related change orders that do not substantially alter the scope of the project.

PROCUREMENT AGREEMENT
(Approved by City Attorney, 1995)

THIS PROCUREMENT AGREEMENT is made this 1st day of July, 2014, between the City of Casper, 200 North David Street, Casper, Wyoming, hereinafter referred to as the "Owner," and Athletica Sports Systems, 554 Parkside Drive, Waterloo, Ontario, Canada, N2L 5Z4 hereinafter referred to as the "Contractor."

NOW, THEREFORE, it is hereby agreed as follows:

ARTICLE 1. GOODS AND SERVICES.

Contractor shall furnish the Goods as specified or indicated in the Procurement Documents. The Goods to be furnished are generally described as follows:

Supply and installation of one (1) complete dashboard, 85' x 200' removable system; team boxes; penalty boxes; scorekeeper's box; camera box; cast acrylic spectator shielding; ice dam; transport/storage equipment; attic stock of spare components; and motorized netting system.

ARTICLE 2. ENGINEER.

The Goods have been specified by the Project Manager, International Coliseums Company (ICC), referred to as the "Engineer" and who is to act as Owner's representative, assume all duties and responsibilities, and have the rights and authority assigned to Engineer by Owner in connection with the furnishing of the Goods and Special Services in accordance with the Procurement Documents.

ARTICLE 3. POINT OF DELIVERY.

The place where the Goods are to be delivered is defined in the Procurement General Conditions as the point of delivery and designated as:

ARTICLE 4. CONTRACT TIME.

4.1 All Shop Drawings and samples required by the Procurement Documents shall be submitted to Engineer for review and approval within fourteen (14) days after the execution of this Agreement by the parties. The Engineer shall return all approved shop drawings and samples with comments to the Contractor within ten (10) days of receipt. If the shop drawings and samples are not approved, the Engineer shall give written notice of the reason for non-approval within ten (10) days of receipt, and parties shall work together in mutual, good-faith

effort to expedite and resolve any outstanding issues within one week of the Engineer's written notice to the Contractor.

- 4.2 The Goods are to be delivered to the point of delivery and ready for Owner's acceptance in accordance with the Casper Events Center – Refrigerated Ice Floor Project Preliminary Schedule included in the bid package prior to issuing final payment.
- 4.4 Liquidated Damages. Owner and Contractor recognize that time is of the essence of this Procurement Agreement and that Owner will suffer financial loss if Goods are not delivered at the point of delivery and ready for acceptance of delivery by Owner within the time specified in Paragraph 4.2 above, plus any extension thereof allowed in accordance with the Procurement General Conditions. Further, they recognize the delays, expense, and difficulties involved in proving in a legal or arbitration proceeding the actual losses or damages (including special, indirect, consequential, incidental, and any other losses or damages) suffered by Owner if complete acceptable Goods are not delivered on time. Accordingly, and instead of requiring proof of such losses or damages, Owner and Contractor agree that as liquidated damages for delay (but not as a penalty) Contractor shall pay Owner Two Hundred Dollar(s) (\$200) for each day that expires after the time specified in Paragraph 4.2 for delivery of acceptable Goods. It is further agreed that such liquidated damages are not a penalty, but represent the parties' best estimate of actual losses or damages.

ARTICLE 5. CONTRACT PRICE.

Owner shall pay Contractor in current funds for furnishing the Goods and Special Services in accordance with the Procurement Documents, subject to additions and deductions by Change Order, the Contract Price of Four Hundred Twenty-Six Thousand Nine Hundred and Forty-Five Dollars (\$426,945). See Exhibit "A" Bid Form, Exhibit "B" Pricing Summary, and Exhibit "C" page 15 of 37 Athletica Sport System Quotes. Contractor must price all bid items and alternates.

ARTICLE 6. PAYMENT PROCEDURES.

Contractor shall submit Applications for Payment in accordance with Article 6 of the Procurement General Conditions. Applications for Payment will be processed through the Engineer as provided in the Procurement General Conditions.

- 6.1 Progress Payments. Owner will make progress payments on account of the Contract Price in accordance with Paragraph 6.3 of the Procurement General Conditions on the basis of Contractor's Applications for Payment as follows:
- 6.1.1 Upon receipt and approval of Shop Drawings, and receipt of the first Application for Payment submitted in accordance with Paragraph 6.1 of the Procurement General Conditions and accompanied by Engineer's recommendation of payment in accordance with Paragraph 6.2.1 of the Procurement General Conditions, an amount equal to five percent (5%) of the Contract Price.

6.1.2 Upon acceptance of delivery of the Goods, and upon receipt of the second such Application for Payment accompanied by Engineer's recommendation of payment in accordance with Paragraph 6.2.2 of the Procurement General Conditions, an amount sufficient to increase total payments to Contractor to ninety percent (90%) of the Contract Price, less such amounts as Engineer shall determine in accordance with Paragraph 6.2.3 of the Procurement General Conditions.

6.2 Final Payment. Upon furnishing of the Special Services, and upon receipt of the final Application for Payment accompanied by Engineer's recommendation of payment in accordance with Paragraph 6.6 of the Procurement General Conditions, Owner shall pay the remainder of the Contract Price as recommended by Engineer.

ARTICLE 7. INTEREST.

No interest shall be paid by Owner to Contractor on retained funds.

ARTICLE 8. CONTRACTOR'S REPRESENTATIONS.

In order to induce Owner to enter into this Procurement Agreement, Contractor makes the following representations:

8.1 Contractor has familiarized himself with the nature and extent of the Procurement Documents, and has given Engineer written notice of all conflicts, errors, or discrepancies that he has discovered in the Procurement Documents and the written resolution thereof by Engineer is acceptable to Contractor.

8.2 Contractor has familiarized himself with all local conditions and federal, state, and local laws, ordinances, rules and regulations that in any manner may affect the production and delivery of the Goods and furnishing of Special Services in connection therewith.

8.3 Contractor does not require additional information from Owner or Engineer to enable Contractor to furnish the Goods and Special Services at the Contract Price, within the Contract Time, and in accordance with the other terms and conditions of the Procurement Documents, but subject to Contractor's right to request interpretations and clarifications in accordance with Paragraph 9.2 of the Procurement General Conditions.

8.4 Contractor has correlated the results of all such examinations, investigations, and resolutions with the terms and conditions of the Procurement Documents.

ARTICLE 9. PROCUREMENT DOCUMENTS.

The Procurement Documents which comprise the entire agreement between Owner and Contractor are attached to this Procurement Agreement, made a part hereof, and consist of the following:

ARTICLE 10. MISCELLANEOUS.

- 10.1 Terms used in this Procurement Agreement, which are defined in Article 1 of the Procurement General Conditions, shall have the meanings designated in those conditions.
- 10.2 No assignment by a party hereto of any rights under or interests in the Procurement Documents will be binding on another party hereto without the written consent of the party sought to be bound; and specifically but without limitation, monies that may become due and monies that are due may not be assigned without such consent (except to the extent that the effect of this restriction may be limited by law), and unless specifically stated to the contrary in any written consent to an assignment, no assignment will release or discharge the assignor from any duty or responsibility under the Procurement Documents.
- 10.3 Owner and Contractor each binds himself, his partners, successors, assigns, and legal representatives to the other party hereto, his partners, successors, assigns, and legal representatives in respect to all covenants, agreements, and obligations contained in the Procurement Documents.

ARTICLE 11. GOVERNMENTAL CLAIMS ACT.

11.1 The Owner does not waive any right or rights it may have pursuant to the Wyoming Governmental Claims Act, Wyoming Statute Sections 1-39-101, et seq. The Owner specifically reserves the right to assert any and all immunities, rights and defenses it may have pursuant to the Wyoming Governmental Claims Act.

Re: Casper Events Center – Ice Floor Project – Evaluation of Dasher Boards and Ice Cover Bid:

The City of Casper and ICC has solicited bids for the purchase of Dasher Boards, Netting, and an Ice Cover for the Event Center Ice Floor Project.

ICC has requested bids from three qualified vendors and the City has also advertised for bids. The City received only one bid from ICC pre-qualified bidders; and there were no additional local bidders. Becker Arena Products acknowledged that they did not have sufficient time to meet our schedule. Cascadia Sport Systems did not return a bid.

This project requires a highly skilled and knowledgeable specialty vendor with manufacturing availability and the required experience of custom engineering, building and installing the boards and netting into our new refrigerated concrete slab floor.

Current events at the Events Center allow only a narrow window of building availability for construction with no event activity on the arena floor. There are costs factored into their bid to accommodate our schedule and the number of trips needed.

ICC has reviewed the submitted bids for accuracy, schedule, cost, and understanding of the project's scope of work and existing site conditions.





This project is to be **Renovation to an Existing Building with a New Refrigerated Slab. Drawings and Specifications provided per Bid Package 14-28B.**

Summary of scope of work by Athletica Sport Systems® will include:

FRAME

- Frames to be structural aluminum and 41" high. Typical 8' length.
- Adjustable pre-cast anchors supplied and Supervised install by Athletica®

INSPECTION

We recommend that you inspect all of the Arena Deck™ sheets as soon as possible after receiving them and report to us any problems, defects or issues. While we employ high quality control standards in production of Arena Deck™ there may be the occasional sheet that has a defect. Every measure is taken in the manufacturing process to ensure our best finished look, however all fiber reinforced polyurethane products are subject to some minor inconsistent surface variables and slight color variations that are inherent to our process and the polymerization of polyurethane foam. These variables in no way affect the structural integrity of the material; nor are they covered under the manufacturer's warranty. Any defects that are found must be reported to Sport Systems Unlimited within 30 days.

INSTALLATION


The Arena Deck™ ice floor cover will arrive at your facility packaged on hardwood skids. Most pallets will contain 50 sheets. If you plan not to use the optional storage carts then retain the hardwood skids. They are suitable for use to store the Arena Deck™ when not in use.

The Arena Deck™ has been designed to have minimal expansion and contraction due to temperature change. However there is a small amount of shrinkage that occurs once the sheet is laid on the ice. It is recommended twenty-four (24) hours prior to the first installation of the Arena Deck™ that the skids be moved into the rink area to acclimatize and cool down. This will help to contract the sheets and ensure a tight installation.



We recommend that the Arena Deck™ is stored indoors, or if stored outdoors, that the sheets are completely covered with a tarp. The UV rays will discolor the sheets and turn them slightly green. The UV will not affect that structural integrity of the sheet, but it will look unsightly. Discoloration from UV exposure is not covered under warranty.

Prior to installation of the Arena Deck™ you should decide on the method of installation that you want. This discussion should include the Operations and Conversion staff. Essentially there are three ways of installing the ice floor cover:

- 1) Interlocking Brick Pattern – Lengthwise
Recommended (see picture right)
- 2) Square Pattern – Lengthwise
- 3) Square Pattern – Widthwise



We recommend the interlocking brick pattern as it helps to secure the sheets in place and does not allow four corners to come together. Over time, the corners of any ice floor cover can become rounded. This can create a hole where the four corners meet.


This document will describe the Interlocking Brick Pattern installation method.

Tools Required

- Hand held circular saw with fine tooth blade (2)
- Saw horses or 4' x 8' work table
- Sharpie black markers (4 to 6)
- 100' chalk line and chalk
- 4' steel straight edge
- 8' steel straight edge
- Steel square
- Tape measure (25' min) steel blade (not fabric or cloth)
- White Paint Pen or similar to mark locations of cut sheets
- Gloves
- Safety Eyewear
- Safety Footwear
- Stabilicers or similar anti-slip soles
- Template of ice rink board radius – 8'
- Note pads
- ShopVac, brooms and garbage bin

Staffing Requirements

For the first installation it is recommended that you employ a supervisor from Sport Systems Unlimited Corp. / Athletica. If you have previously installed an ice floor cover, a supervisor is not a necessity. You should have four to six (4-6) conversion or operations staff involved in the initial installation. In addition you should have one or two carpenters or similar trained personnel to cut the sheets. The first installation will take eight to ten (8-10) hours. Allow enough time between events to ensure that the installation is completed and that there is time to remove the ice cover once it has been cut and marked.





Step 1. Before installing any sheets make sure that the ice has been scraped and is dry. It is not recommended to floor the ice prior to installation of the ice floor cover as it makes it more difficult to walk on the ice and the sheets tend to slide. Also we recommend that you use a power edger and a manual ice scraper to remove any build-up of ice around the perimeter of the rink boards.

Step 2. Choose one side of the rink to begin the installation. From the center of the red line make a mark on the kick plate 4' down from center. Do this on the opposite side of the rink also. Stretch the chalk line across the width of the rink and snap a line 4' back from center. This line will be used to create the brick pattern and to ensure that each subsequent row of the ice cover is installed straight.

Step 3. Start installation of ice cover by laying the first sheet against the boards at center ice. Make sure that this sheet is properly located and tight against the boards



Step 4. Install additional Arena Deck™ sheets down the length of this side until you reach the start of the radius of the boards. Take caution to ensure that the sheets don't slide on the ice. Check frequently to see that the center sheets are still on the lines.








Step 5. Once the first row is complete to the radius, begin the next row at center ice. Stagger the second row using the chalk line to offset the sheets 4'. When installing the second row always take care that the second row is tight to the first. You will find that lightly kicking the center of the sheet will keep the rows aligned and the sheets tight.



Step 6. Continue to install additional rows of sheets up to the radius of the rink. Do not cut the radius corners in at this point. Make sure that the rows are tight and there are no gaps between the sheets.






Step 7. Once all of the rows have been installed you will need to cut a sheet lengthwise for the final row. On an 85' wide rink this final row will be 9" – 12" wide. Cut one or two pieces of 8' long sheets to the proper width and install them snugly against the kick strip. This will help to lock the floor in place while cutting the radius corners and end pieces.


Step 8. Cut pieces to fill in the gaps at each end of the rink. Once complete you can begin measuring and cutting the radius corners. Each radius piece will need to be measured and cut. Many ice rinks have variations in the radius from corner to corner and even through the radius itself.

Step 9. Once the entire ice floor cover is installed the custom cut pieces will need to be marked by location using the white paint pen or similar utensil.



OPERATIONAL CARE AND MAINTENANCE

Your new Arena Deck™ ice floor cover is relatively simple to use clean and maintain. The sheets are manufactured from polyurethane foam and will not absorb moisture or odors. A few simple steps will keep your ice cover looking and smelling clean.

Operation

Prior to installation of the ice cover make sure that the ice is dry and has been shaved. It is recommended that you use a power edger and hand scraper around the perimeter of the rink boards to ensure that there are no bumps or uneven areas.

Do not drive forklifts or carts over the ice cover until it is completely installed.

Once the ice cover has been installed it is important to keep an eye on the ice temperature below the cover. As the Arena Deck™ has insulating properties it will help to isolate the ice from the various heat loads inside the rink (radiant, ambient, lighting etc.) If the cover is down for an extended period of time the ice temperature may drop significantly if not controlled. A large drop in ice temperature can cause the ice cover to become cold and drop below the dew point in the rink area. If this happens moisture may condense out on the top side of the ice cover. This is an uncommon occurrence but can happen under certain conditions.




The Arena Deck™ can be left on top of the ice for extended periods of time without the worry of it sticking to the ice.

Cleaning and Maintenance

When ready to store until the next event, a mild soap and water mixture with a low pressure washer or floor scrubber will adequately clean the panels. Store the panels away from direct sunlight on pallets or carts, and stack horizontally.

Once a year, a thorough cleaning of the Arena Deck™ can be done with a low pressure sprayer and mild soap.

The use of harsh cleaning chemicals is not recommended. If using anything other than soap and water, test on a small inconspicuous area first to observe the effects.
