SUBJECT: Review of the applications for the Retail Liquor License.

Recommendation:

That City Council consider six (6) applicants for the one available Retail Liquor License to move forward in the formal application process.

Summary:

At a Council work session held on May 10<sup>th</sup>, 2016 City Council supported the recommendation by City staff to accept applications and proposals for the one available Retail Liquor License, with restrictions on this one license to keep in line with Council goals for the downtown development. The application process was opened on June 1, 2016 and closed on June 30, 2016 for the available Retail Liquor License. Notification was done by advertising on the City of Casper website, the local newspaper, and by press release.

On June 30, 2016, City staff received six (6) proposals for the one available Retail Liquor License. This license will be restricted to the downtown area and will be assigned to a location and it will not be transferred from this location. Requests were to include a clear, concise business plan and a site plan with public parking clearly identified. The business plan was to include how the issuance of this license would contribute to the economic development goals or purposes of the City, whether the applicant will be investing in the construction of a new structure or will otherwise be materially and substantially updating a current building, and the number of new jobs reasonably estimated to be created.

In Wyoming, the number of Retail, Bar & Grill, Micro-brewery and Winery Liquor Licenses authorized to be issued by local governments is determined by the population of the city, town or county. Between the ten-year censuses, a mid-decade evaluation is conducted to estimate the populations of Wyoming local governments. They are evaluated by the Wyoming Department of Revenue – Liquor Division to determine the number of liquor licenses available for issuance.

The City Council issued Retail Liquor License Number 36 to Urban Market Wines, LLC in 2014, with conditions and restrictions that bind to all owners, or successors, as well as all operations under said license. This license is restricted to 319 West Midwest and is not eligible for transfer to any other location. Its use on real property may be transferred to a new owner or lessee of the real property upon approval by the City of Casper. Upon termination of the use of this Retail Liquor License by the applicant, this Retail Liquor License shall revert, and become the property of the City of Casper. The conditions and restrictions shall continue to attach to and bind said license and owners, transferees, successors or assigns until removed by formal action from City Council. These restrictions were placed on the license to bolster the development of the Old Yellowstone District.

In May of 2015, at the mid-year census, an additional Retail Liquor License, and an additional Bar & Grill License were issued to the City of Casper. Council decided at that time that the Retail Liquor License would be set aside to evaluate how to best ensure the issuance would incentivize development and continue to retain the benefits of the License. The additional Bar & Grill License was assigned to Marco's Coal Fire Pizza d.b.a Racca's Pizzeria Napoletana located at 319 West Midwest in the Old Yellowstone District in September 2015.

### **Bar & Grill Liquor Licenses**

When the Bar & Grill Liquor License type was originally authorized by the Wyoming Legislature in 2006, the issuance process was an ongoing application process with applications accepted anytime applicants chose to apply as long as licenses were available. For these licenses Council adopted issuing preference criteria. The section of the Casper Municipal Code containing those criteria follows:

#### **508.285 – Bar & Grill liquor license issuance, council authority, criteria and restrictions.**

- A. Subject to availability, restaurants, as defined by subsection 19 of Section 5.08.010 of this chapter, may be licensed by the City Council under a Bar & Grill liquor license. In addition to the application requirements required by this chapter, the license applicant shall submit a valid food service permit issued by the State of Wyoming upon application. Criteria that may be considered by the City Council in determining to whom any such license may be issued may include, but is not limited to the following:
1. The location of the proposed business is in an area: (1) in need of redevelopment; (2) officially designated as an urban renewal area; or (3) that has been identified as being under-served by food and beverage services.
  2. The issuance of the license will contribute to economic development goals or purposes of the city.

3. Whether the applicant will be investing in the construction of a new structure or will otherwise be materially and substantially updating a current building.
4. If the applicant's business is a new business, the number of new jobs reasonably estimated to be created, or if an existing business, the number of new or additional jobs that will reasonably be created by use of the Bar & Grill liquor license.

The clear focus of the issuance criteria for Bar & Grill Liquor Licenses as specified in paragraph 2 above, was to use the licenses as development incentives for the community.

Applications for Bar & Grill Liquor Licenses have been accepted as long as there were unissued licenses available and whenever an applicant identified a desire to obtain a license.

### **Retail Liquor License**

As was for the issuance of the Bar & Grill Liquor Licenses, using liquor licenses as a development incentive also applied for the issuance of the additional Retail Liquor License authorized for the City of Casper as a result of the 2010 census. Transfer and location restrictions were placed on that license to bolster the development of the Old Yellowstone District.

City staff reviewed all applications for the required criteria and all six (6) applications met the criteria. The applications received and a brief description of the proposed business and facility are as follows (map attached):

- Charles T. and Merry Jane Walsh d.b.a The Wolcott Galleria – 136 South Wolcott Street.
  - This plan involves remodeling the existing Wolcott Galleria building especially in regards to creating a space for a “Speakeasy” bar and restaurant.
  - This proposal is a multi-floor venue with bars on floors 0 and 2, with a “Speakeasy” style restaurant on floor 0 and wine service at the existing Vita Sana Olive Oil retail store.
- Citizens for a Civic Auditorium d.b.a The Lyric – 230 West Yellowstone.
  - This applicant purchased the Iris movie theater in 2015 and remodeled the lobby.
  - They plan to extensively remodel this building to make it a full scale performance venue. Architectural designs include a concession area in the lobby with a dispensing room.
- Plattebread, LLC. d.b.a Plattebread – 451-499 West 1<sup>st</sup> Street.
  - This applicant intends to build a new building on an existing plot of land.

- This venue will be showcasing a comprehensive selection of Wyoming Microbrews, fine wines, and cocktails. It will also be a lunch and dinner restaurant that mashes up a Euro-Italian inspired menu. Connected to the bar and grill will be an espresso café serving Casper-roasted coffee as well as tea.
- Charger Holding, LLC. d.b.a Yellowstone Garage Bar and Grill – 355 West Yellowstone.
  - This proposal does not explicitly describe any remodeling plans.
  - The venue will be promoted as a family style Bar & Grill featuring craft beer at the existing Yellowstone Garage building.
- The Chelsea Group of Wyoming d.b.a Jacquie’s Bistro, Brunch and Bar – 124 East Second Street.
  - This applicant will be remodeling and expanding the existing Jacquie’s Bistro into a bar and entertainment venue.
  - In the future the applicant is anticipating adding a piano bar and ice cream parlor. The applicant is also interested in adding the building to the National Historic Register.
- Roaring 22, LLC. d.b.a Roaring 22 – 314 Midwest Avenue.
  - This applicant intends to renovate the old Houston Supply Building into a mixed-used facility complete with a Live, Work, Play environment.
  - This venue is proposed as a contemporary pub and grill highlighted by its selection of beer on tap with half being from local breweries. This venue will also feature a 5,000 square foot brewery named The Lab, tap house, amusement and event space.

Per Ordinance 5.08.150 the City Council may issue less than the total number of allowable liquor licenses allowed by State Statues.


If a selection is made by City Council, that applicant will move forward to be processed through the regular liquor licensing procedures. The application will be reviewed by the Wyoming Liquor Division, City of Casper Planning and Zoning, City of Casper Fire Department and Natrona County Health Department to begin the process for issuance.

# Casper, Wyoming Liquor-License Businesses: Current and Proposed July 2016







The Board of Directors of the Citizens for a Civic Auditorium plan to design, construct and operate a new performing arts center for Casper and Central Wyoming. The 501(c)(3) non-profit organization recently purchased the former Iris movie theater and have renamed it, The Lyric.

The Lyric is applying for the open Retail Liquor License for the City of Casper. The liquor license application and attachments are included in the binder.

The Lyric is currently:

- Updating the 2012 Business Plan with Community Builders, Inc.
- Developing a Strategic Plan with a Timeline for Tasks
- Developing the Conceptual Design into Detailed Construction Plans with Amundsen Architects
- Developing Accounting Procedures and Verifying Finances with Lenhart Mason
- Determining Fundraising Capabilities and Developing Strategies for a Successful Capital Campaign
- Conducting Interim Operations at the Former Iris theater to Bring Awareness to the Project, to Support the Ongoing Operational Costs and to Raise Funds for the Capital Campaign

As part of the strategic planning process and updating the business plan, board members and staff toured similar performing arts venues in the region. From the regional tours, some major changes were identified that will be addressed in the updated business plan. The changes include additional employees to adequately staff the planned venue, potential construction cost reduction from value engineering and economic conditions, and revenue generated from concession sales for food and alcohol. It is extremely important in the updates to the business plan for The Lyric to obtain a liquor license. The Lyric expects to have liquor sales opportunities well beyond the

annual allotment of catering and malt beverage permits. The model of the Alberta Bair Theater in Billings, Montana, shows over \$100,000 in revenue from alcohol and concession. The liquor license will be a critical step in meeting the performing art center's operating costs.

The Lyric is currently operating as a rental venue for events. The Lyric has hosted a Wyoming Symphony Orchestra fundraiser, Wyoming Community Foundation Dinner, Art Walks, school parent group meetings, Casper's 3x3 basketball tournament, wedding receptions, community board meetings, a weekly church service, Archery Hunting Expo, and a Rotary Governor's dinner. The Lyric plans to host 4-6 events per month and will quickly outgrow the limited catering and malt beverage permits.

If the Lyric is approved for the Retail Liquor License associated with the construction of the new performing arts center, we would like to meet with you to discuss the potential interim rental venue operations. The Lyric can quickly modify the existing catering area in the current building configuration to meet with code requirements for a dispensing room. If approved for the retail liquor license, The Lyric could begin immediately using the license for the interim events. The additional revenue earned from alcohol sales could substantially help the Lyric cover operating costs to further the cause of building the performing arts venue.


