

Question 3: Is negative 15 degree testing acceptable on the ADA ramp?

Answer: Yes.

Question 4: Can the lower body paint be wrapped 3M with 5-year warranty to the color spec provided

Answer: Yes, a wrap in the proper color will be acceptable.

Question 5: Can we provide grab bars mounted on the B and C Pillars instead of ceiling mounted grab bars?

Answer: Yes, grab bars mounted on the B & C- Pillars are acceptable.

Question 6: Will OEM AWD be accepted as for four-wheel drive?

Answer: Yes, OEM AWD is desired. Four- wheel drive conversions will not be accepted

Question 7: Ford does not offer fast idle control. Is an aftermarket solution acceptable?

Answer: Yes, idle control should be InterMotive, supplied by an up-fitter.

Question 8: Are camera displays in the stereo display screen acceptable?
