

# Conditional Exempt Small Quantity Generator [CESQG] Of Hazardous Waste Certification Agreement

The City of Casper's CESQG program is limited to accepting only hazardous waste exempted under federal and State of Wyoming regulations pertaining to CESQG exemptions. A general overview of the CESQG exemption regulations is as follows: A CESQG must generate less than 220 lbs or 25 gallons of hazardous waste per-calendar month or less than 2.2 lbs or ¼ gallon of acute hazardous waste per-calendar month. A CESQG must never accumulate more than 2,200 lbs or 220 gallons of hazardous waste or 2.2 lbs or ¼ gallon of acute hazardous waste on-site at one time. I assume full liability for Company's waste and hereby release the City of Casper, its elected and appointed officials, Manager, officers, employees, representatives, agents, and contractors [subsequently referred to as "Releasees"] from any and all liability, responsibility, claims, demands, actions, or causes of action whatsoever arising out of Company's waste. I specifically release and discharge Releasees for liability for any injury, death, damage or loss of property arising out of the negligence, active or passive, of any Releasees, or from some other cause associated with Company's waste. I understand that I am giving up legal rights which I may otherwise have by entering into this Agreement.
